Archives Committee Acquisitions Policy

The purpose of the Leisure World Historical Society, according to the Articles of Incorporation, is "To collect, preserve and own such records, books, manuscripts, charts, maps, photographs, films and other materials pertaining to the history of Rossmoor Leisure World of Laguna Hills and its surrounding environs in Orange County, California, to engage in research in connection therewith and to disseminate information to the public so as to foster knowledge and appreciation of the people and events that contribute to such history—"

In order to accomplish this purpose an Archives Committee has been established and will use the following guidelines concerning what materials should be retained, in what quantity, etc. These guidelines include the following type of acquisitions:

SUBJECT FILE: clippings and flyers from Airplane Crash, 1967, to material regarding James H. Zumberge. The file includes Biographical material, copies of profiles of notable residents as well as Oral history tapes, some of which have been transcribed. The file is cataloged with easy access to finding the material wanted.

CLUB FILE: File of material regarding the 150 to 200 clubs in Leisure World from AARP to the Writers & Publishers Club of Leisure World. The file contains histories regarding many of the clubs, both currently active and some of which are no longer in existence.

PERIODICALS: Included here are copies of the Annual Reports of the various mutuals, as well as a limited number of current historical publications such as "The Californians" and "History News."

PHOTOGRAPHS: This file contains photographs in acid-free envelopes filed by subject from Aerial views of Leisure World to the Twentieth Anniversary celebration and Veterans of World War I. There is an alphabetical list of subjects for easy access to the file.

SCRAPBOOKS: We have a number of scrapbooks from various clubs including the Naturalist Club, the Organ Club, Opera 100 and the Stamp Club. Also a number of club directories and/or rosters are included.

There are also scrapbooks of publicity related to the Leisure World Historical Society and other scrapbooks of clippings related to the community in general.

LEISURE WORLDER OF THE MONTH: We have Annual volumes of the Leisure Worlder of the Month containing a black and white photos of those honored since 1976 when the program began as well as albums arranged alphabetically of the colored photos.

MEMORABILIA: In addition to the above we have some flags, plaques and trophies.

NEWSPAPERS: We have files of Leisure World News back to vol. 1, no. 1, March 17, 1965. These are stored in acid-free boxes to preserve them as long as possible and are kept in our storage annex on Moulton Parkway.

In addition to all the above we have some collections of special people like Marjorie Jones who was instrumental in founding the society and M.H. "Jim" Waterman, President of the society from 1980 to 1984.

Leisure Worlder of the Month by Eitor

The Leisure World Historical Society deeply appreciates the opportunity to cooperate closely with Home Federal Savings and Loan Association in the "Leisure Worlder of the Month" program devoted to the recognition of residents of our community.

In January, 1976, this program was initiated by Rossmoor Corporation. The presentation is accomplished at a public ceremony to which all residents of Leisure World are invited. The portrait and testimonial are made available for public viewing for one month. When the next Leisure Worlder of the Month is honored the portrait and testimonial are presented to the previous one as a gift.

In August, 1981—after some 67 ceremonies had been held by Rossmoor Corporation, Home Federal Savings and Loan Association took over the program, thus assuming the responsibility of presenting the honorees, preparing the portrait, and doing the necessary public relations.

At this time the Leisure World Historical Society was asked to consult and recommend the selection of honorees. This has been accomplished since then through an anonymous committee whose names are kept secret. The society also participates in the monthly ceremony with one of its members serving as chairman or moderator.

It is the mutual desire of both Home Federal Savings and Loan and the Leisure World Historical Society to continue this program. With residents from around the world, with distinguished careers before and after coming to Leisure World it is only fitting that we recognize those qualities of service and leadership that contribute so much to our community.

Joint Meeting

The Leisure World Historical Society met jointly with the Saddleback Area Historical Society at Heritage Hill Historical Park, 25151 Serrano Road, El Toro, at 2 p.m. on Sunday, May 19, 1985. The purpose of the meeting was to dedicate the Harvey Bennett Ranch House.

After appropriate opening remarks and introductions, the Saddleback Area President presented the speaker.

Nadine Zelenka, an avocational archaeologist, had worked as a geologist at the Bennett Orchard site dig. She described the interdisciplinary approach made at the site during 1977-78. The ranch had been bisected by Aliso Creek. The creek meandered around disturbing the site area and making the dig more difficult. The ranch had been an Indian camp site occupied seasonally until about 1500 A.D.

Mrs. Harvey Bennett unveiled the plaque on the house. She related some of her experiences during her 65 years on the ranch. The house had originally been a two room bunk house.

Bennett family members were introduced and photographed. They gave the Saddleback Historical Society the wedding portrait of the Bennetts.

Docents led tours of the buildings. Refreshments were available.

Financial Reports

While we are not quite to the end of 1985 as this report is being written, we can make a good estimate of our financial results for the year.

We received \$3,200 from annual dues and \$400 from new Life Memberships. Contributions from banks and commercial establishments amounted to \$1,665, which is considerably less than in some prior years. Interest on our savings account, and miscellaneous items, totaled \$1,320, bringing our total income to \$6,585.

Since the very purpose of the Historical Society is to "Collect," we have a growing volume of Archives. Most of this material is stored in a public storage unit. The annual rent for this storage space and for our office in the Administration Building is \$2,450. Payroll and related taxes for our part-time secretary amounted to \$3,220. Supplies, postage, insurance, and publication of "Historical Hi-Lites" cost \$1,950, bringing total expenses to \$7,620.

Thus our operating expenses exceeded income by about \$1,035, which has been drawn from our savings reserves.

Since our Archives will continue to expand as we pursue our purpose of preserving the history of Leisure World, we must find sources of additional income. Your Board of Directors will be exploring this need during 1986.

Music for dancing and listening pleasure will be provided by Vern MacGuire and The Leisure World Combo.

Program Committee

It has been the practice of the Leisure World Historical Society to hold a series of six meetings and a special events during the year. Such exposure not only brings members up-to-date on the happenings of the society, but also gives the society the opportunity to stimulate new membership.

Two of the meetings in 1985 were of the general meeting type. One held March 28, 1985 at which the election of officers and directors was conducted along with a fine speech by Dr. Norman Freestone talking on "Mark Twain and the Far West" and the other meeting on October 22, 1985 featuring membership promotion and archives presentation as well as a speech by Dick Hauptfleisch on "Banking—present and future."

On January 14, 1985, a dinner dance was held at Clubhouse 1 and six individuals were honored for extraordinary service towards the success of Leisure World. On February 19, 1985, the Community Service Committee presented a program at Clubhouse 3 in the auditorium at which the speaker was James Zumberge.

The luncheon meeting on April 19 at Mercury Savings featured an interesting talk by Dean Beaumont, son of famed seascape artist Arthur Beaumont, who talked and presented slides about how his father completed his famous paintings of ships. On Sunday, May 19, a joint meeting was held with the Saddleback Area Historical Society at Heritage Hill in El Toro—an informative event.

Although plans have not been completed for the 1986 programs, it will have the same format as 1985 with six programs. The Recognition Dinner-Dance honoring six more honorees will be held on Monday, February 3, 1986 in Clubhouse 1 with Jim White in charge. Other dates include Community Service Program on February 18, Annual Meeting and Election on March 25, Luncheon at Mercury Savings on April 15, Joint meeting with Saddleback Area Historical Society on May 13, and General meeting on October 28.

Space Needs

The society is severely cramped, especially in view of its many activities which involve collection and storage of historical data, artifacts and documents of all kinds. It has been the hope of all our members to acquire additional space. If there is any question as to our needs, please come by our office in the Administration Building and look us over.

We have been forced to rent two commercial-type lockers on Moulton Parkway near Lake Forest Drive. Even with these additions for dead storage there is a continuing need to expand.
