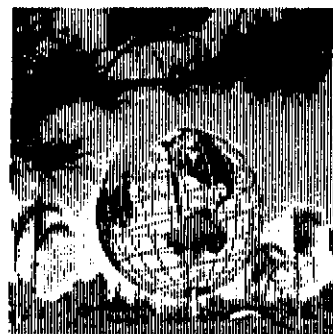

**"LEISURE WORLD COHORT STUDY
of
HEALTH PROMOTION AND DISEASE PREVENTION"
Is Topic At HISTORICAL SOCIETY MEETING
TUESDAY, FEBRUARY 18
2 P.M. Clubhouse Three D.R. 1**

Ronald K. Ross, M.D., co-investigator with Annlia Paganini-Hill, Ph.D., of the University of Southern California's Leisure World Cohort Study, will be the featured speaker at the February Historical Society meeting.

Some ten years ago, in 1981, USC researchers mailed questionnaires to all 22,791 residents of the Laguna Hills retirement community of Leisure World. Sixty-one percent of the residents responded, creating a remarkably detailed study into the aging process.

That research goes on today, with Dr. Ross and Dr. Paganini-Hill continuing to track the health and habits of two-thirds of the original respondents. Dr. Ross, who is also employed by the Norris Cancer Hospital in Los Angeles, will discuss the 10-year-old Cohort Study and its findings, and the projected Lifetime Cable television program being planned about it.

Wrapping up the program will be Albert L. Hanson, prominent Leisure Worlder and former Chairman of the Board of Councilors, USC-Gerontology Andrus Center. Mr. Hanson will give a brief update on that Center's latest research findings.

TREASURER'S REPORT

Leisure World Historical Society had a very satisfactory year financially in 1991. Our income amounted to \$7,834, and expenses were \$6,341, leaving a net income of \$1,493 to add to our accumulated surplus.

As usual, the largest source of income was from dues and contributions. We were gratified that over 25% of our total membership of individual, associate and life members contributed more than the basic dues of \$10, some as much as \$300. This indicates a real interest in the objectives of the Society to collect, preserve and publish the history of the Leisure World Community.

In addition to the dues and contributions of \$5,371, we earned interest of \$1,692 on our invested reserves, and \$471 from the sale of our publication.

Our principal expense was for payroll and required taxes and insurance for our part-time office secretary and for membership in historical associations, amounting to \$5,119. Postage and supplies and materials for storing and protecting our archives totaled \$1,158. The net cost of the bus excursion to the Richard Nixon Library and to hold two public meetings was a modest \$64. Total operating expense was \$6,341.

The net income for the year, \$1,493, brings our total accumulated reserves to \$25,045. In addition, we have a Memorial Fund of Special Contributions and Bequests totaling \$2,790. This includes a bequest of \$1,000 from the estate of Marjorie Jones, one of the founders of the Historical Society.

All of our funds are held in three banks in accounts covered by federal insurance.
